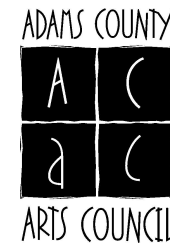

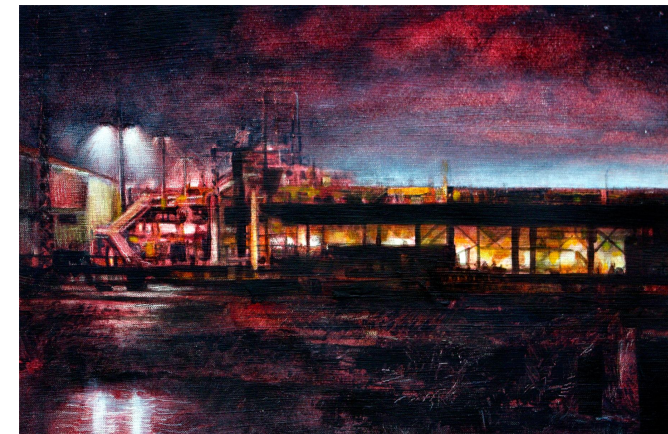

To submit work for consideration by juror review, please complete and submit this entry form with the \$25 entry fee and digital (.jpg file format only) photographs on a single, otherwise blank CD (containing no software). E-mail entries will not be accepted. Submit one jpg photo for 2-dimensional and two jpg photos for 3-dimensional work. All photos submitted should be submitted on the same disc. Please use permanent marker, not a paper label, to identify the CD with your name. A maximum of three (3) pieces per artist may be submitted. Works can be no larger than 60 inches in any direction, including frame. CDs will **not** be returned.

- All entries of original art must be the submitting artist's own original work, completed within the past three years.
- Entries may NOT have been accepted for exhibition in any prior ACAC juried art show.
- The ACAC and Schmucker Art Gallery reserve the right to reject any work.
- All works must be free standing or ready to hang with appropriate hanging hardware.
- Works must be labeled with title, date, price or NFS, and artist's name. Please factor framing costs into the retail price.
- No prints or copies of original works will be accepted. Computer prints will be considered original art only if accompanied by the artist's statement confirming same.
- Once an item has been entered and accepted it may not be **withdrawn** or the conditions of sale changed without the consent of the Art Exhibition Committee.
- Art sales do not include reproduction rights. The artist and buyer must negotiate separately.
- Art work receiving request of purchase will be sold on a 'first-come first- served' basis.
- Any art work purchased but not collected by the buyer will be retained by the ACAC, which will make every effort to contact the buyer. If ACAC is unable to complete the sale within 3 months, the art will be returned to the artist.
- ACAC, Gettysburg Festival and Schmucker Art Gallery reserve the right to photograph work for publicity and education purposes only. If you object to having your works used, with credit, by press reviewing the exhibition or by ACAC, Gettysburg Festival and Schmucker Art Gallery, please indicate this in writing and attach to your entry form.
