#### General Rules:

#### See General Fair Rules and Regulations.

1. All equipment must be in operating condition and should indicate the year it was manufactured, if known.
2. If you would like to demonstrate your equipment, contact the South Mountain Fair Association in advance to determine if space is available. When demonstrating, please follow all safety rules and be aware of the public in the area around your display.
3. Limited exhibit space has been provided. Space will be limited to 3 pieces of equipment per exhibitor. Pre-registration is required. Pre-registration is April 1 to July 14, and must be in Joanne Irvin's possession NOT postmarked as of July 14. Entries received after July 14, will be accepted at the discretion of the chairperson and the South Mountain Fair Association. Registration forms are available online at [www.southmountainfair.com](http://www.southmountainfair.com) or in the premium book.
4. Entries receiving prize money the previous year are only eligible to receive a ribbon the next year.
5. Exhibits previously receiving **Best of Show** may show the item for display only, and not as part of the competition.
6. Each exhibitor must secure an exhibitor's number. Fee is \$2.00, unless you mail your pre-registration in advance. (then it's free) Numbers can be obtained on the grounds Sunday and Monday during registration times. (Please DO NOT send money with this form).
7. **Exhibits will be accepted on Sunday July 29, 2018, from 2-4 p.m., and on Monday, July 30, 2018, from 4-8 p.m.** The department 24 registration form on the next page should be mailed by July 18 as indicated on the form.
8. **Only livestock may be removed Saturday night. Equipment may be removed after the Fair on Sunday.**
9. Please remove any and all name tags (identifying owner) from equipment until after judging is complete.
10. Pre-registration paperwork will be kept by Department 24 personnel, and will be available when you bring your exhibits to register.
11. The Department 24 committee will make the final decision on classification of each exhibit.
