# Town Manager's Report MARCH 2012

### Streets:

- Staff made several "cold patch" street repairs.
- Staff repaired a number of street lights.
- Staff cleaned East and West Main Street.
- Staff painted curbs yellow in front of fire hydrants.

#### Water:

- Rainbow Lake is at the spillway level.
- The roughing filters are being backwashed twice per day and the DE filters are being done once per week.
- Staff sanded and repainted DE Filter No. 1.
- Our wells are now averaging about 4.6' below their May 2011 levels.
- Water production and consumption. We produced and purchased an average of 266,287 GPD. We consumed an average of 238,997 GPD.

The difference is "Backwash Water" ... (10.2%). We purchased 109,925 gallons of water from MSM this month.

- o 35.7% of this water came from wells.
- o 1.3% of this water came from Mt. St. Mary's.
- o 63.0% of this water came from Rainbow Lake.

#### Wastewater:

- The overland flow treatment system is operational for the season.
- The well and stream monitoring has been completed for March.
- We received about 2.3" of precipitation this month (the average is 3.9").
  - We have a precipitation **DEFICIT** of 2.9" over the last six months. The average precipitation for the period from October 1 thru March 31 is 21.2".
     We have received 18.3" for that period.
- Wastewater Treatment:
  - We treated an average of 468,000 GPD (consumed 238,997 GPD) which means that 48.9% of the wastewater treated this month was "wild water".
  - We had no spills of untreated sewerage in the month of March.
  - We exceeded the plant's design capacity on 4 days in the month of March.
